Course Description

This qualification applies to people working in the maritime industry seeking an Australian Maritime Safety Authority (AMSA) certification in the capacity of Master on vessels up to 45 metres in length within the exclusive economic zone (EEZ).

Duties and Functions

Duties and functions for which AMSA certificate of competency is required are listed in the MAR Maritime Training Package Companion Volume Implementation Guide.

Licensing/Regulatory Information

This qualification is currently cited as meeting some of the requirements for certification as:

- Master up to 45 metres Near Coastal as specified in Marine Order 505
- Chief Mate up to 100 metres Near Coastal as specified in Marine Order 505.

Certification as a Master up to 45 metres Near Coastal will require achievement of:

- MAR40324 Certificate IV in Maritime Operations (Master up to 45 metres Near Coastal), and
- Certification as a Master up to 24 metres Near Coastal,
- long range operator Certificate of Proficiency (LROCP) issued by ACMA (or higher qualification),
- having passed final assessment as specified in Marine Order 505 and
- holding a current first aid certificate as specified in Marine Order 505.

Seafarers seeking certification should check with AMSA.

SELECTION CRITERIA

You will also be required to hold a MAR30924 (or equivalent) Certificate III in Maritime Operations (Master up to 24 meters Near Coastal), and hold at least 80% of the AMSA (Australian Maritime Safety Authority) sea time requirements or completed task book. Refer to AMSA's M45 Entry Requirements for further details on sea service requirements and submitting evidence.

To ensure you have the right skills and support to succeed in your course, a Language, Literacy, and Numeracy (LLN) evaluation helps identify any areas where you may require additional support to help you achieve your goals.

Due to the physical requirements of this unit the student must have the ability to perform significant tasks consistent with maritime operations in and on vessels and be physically fit.

Students will be required to provide their own digital devices, able to access reliable internet and have video recording capabilities to record and submit assessment. Including access to:

- Internet access through Google Chrome or other internet browsers
- MS Word, MS PowerPoint or equivalent applications
- Adobe Acrobat Reader

Reading and writing - a learner will be able to read, comprehend and write a range of texts within a variety of contexts.
